Introduction

Thank you for purchasing the Yamaha BTR-STP200. This product is a rechargeable lithium ion battery pack.

This Owner's Manual describes precautions for using and recharging the battery pack.

Please be sure to read this Owner's Manual before using the product to take best advantage of the product's features.

After reading this manual, please keep it in a safe place.

PRECAUTIONS

PLEASE READ CAREFULLY BEFORE PROCEEDING

Please keep this manual in a safe place for future reference.

Please read the Owner's Manual carefully and use the product correctly. If you use the product incorrectly, bodily injuries or burns, leaking liquid, overheating, explosion or damage to the product may result.



WARNING

Always follow the basic precautions listed below to avoid the possibility of serious injury or even death from electrical shock, short-circuiting, damages, fire or other hazards. These precautions include, but are not limited to, the following:

Do not open

- This product contains no user-serviceable parts. Do not attempt to disassemble the internal parts or modify them in any way.

Water warning

- Do not expose the product to rain, use it near water or in damp or wet conditions, or place on it any containers (such as vases, bottles or glasses) containing liquids which might spill into any openings.
- Never charge when this product is wet. Doing so may cause electric shock, fire, or malfunction due to short circuiting.

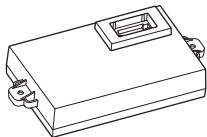
